Municipal Fiscal Need Assessment:

- **The Majority of City Municipal Governments across the countries of Europe, States in the U.S.A. and Prefectures in Japan, don't have the Tax Base that will allow Debt Service on Municipal Bonds issued to Fund Flood Control Water Works Projects, to prepare for Electric Car Recharging Grids.**

Solution – Municipal Economic Development Tax Lock Box:

Thus, allowing small Manufacturing Plant Industrial Parks to be developed in Japan and France, as well as in their Manufacturing Sister Cities.

Davis has developed an Economics of Scale Business Model that allows for the Tax Based that will be Created by the Manufacturing Plant Industrial Parks in Japan and France, to be adequate to Service the Debt on Municipal Bonds that will be Issued to Fund Flood Control Water Works Projects.

 - c. Cost Estimate to build River Levee Flood Control Systems to prevent Flooding.
 - d. Cost Estimate to build Water Retention Ponds to contain Water from accumulating to Flood.
 - e. Cost Estimate to Remove and Replace City Municipal Water Supply Pipelines under Streets.


Job Description # 2: Electric Car Wireless Recharging Grid in City Streets / Development Consultant
